Physical Damage

Flat rate repairs reflect pricing for radios/repeaters which have not been physically damaged. Radios which exhibit signs of physical damage, may require more than basic repair and therefore have additional fees. Physical damage including but not limited to water damage may render the device non-repairable. A quote will be provided prior to work commencement for any item not listed on this flat rate repair schedule.

In-Warranty Firmware Upgrade & License Application

For warranty radios, Hytera offers free firmware upgrade and license application prior to shipping the PO. However, \$50/unit will be charged if later customer wants Hytera to upgrade firmware or apply license. An RMA shall be submitted by customer, and customer pays inbound shipping and Hytera pays outbound shipping as normal. Dealers are encouraged to do such task themselves.

Trade-in Program

To improve the utilization of legacy products, if DMR radio has been used for more than 6 years (Date of manufacture) or with firmware prior to version R6.0 can't be upgraded to the latest i-Series firmware. Hytera offers trade in program allowing dealer to trade in the old radio and receive \$50 credit towards the purchase of the new radio.

Diagnostic Fee

To further root cause an out of warranty issue, unit may be subjected to \$25 diagnostic fee for open case investigation. If the dealer decides not to repair the unit, the diagnostic fee will be billed to the dealer with the return shipping cost; If the dealer approves the repair, the diagnostic fee will be credited back towards the actual repair cost.
